Bond Rider Accepted Obligation Under Bond Increased

The BLM Nevada State Office (NSO) currently holds BLM bond number NVB002048 with Belmont Nevada Inc, as principal. The bond provides surface reclamation coverage for operations conducted by the principal on NVN094992, the Kibby Basin Lithium Exploration Project.

On May 22, 2018, the NSO received a bond rider increasing the penal sum of NVB002048 to \$43,580. The rider has been examined, found satisfactory, and is accepted effective May 22, 2018.

On May 15, 2018, the BLM Tonopah Field Office increased the reclamation cost estimate on NVN094992 to \$43,578. Effective the date of this Decision, NVN094992 is satisfactorily bonded under NVB002048 in the amount of \$43,578.

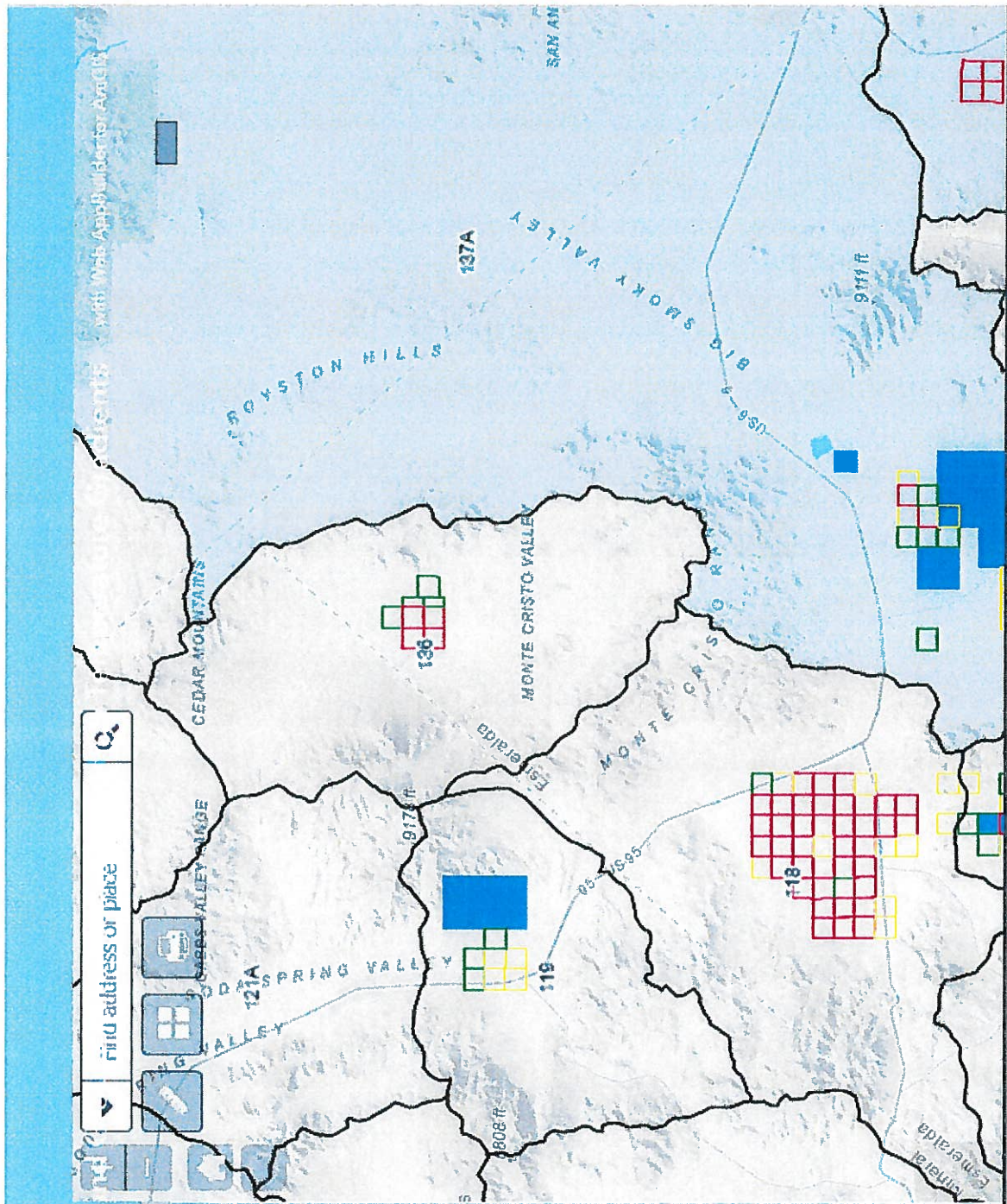
Considering the bond amounts accepted and obligated, \$2 is available under NVB002048 for future amendments to NVN094992.

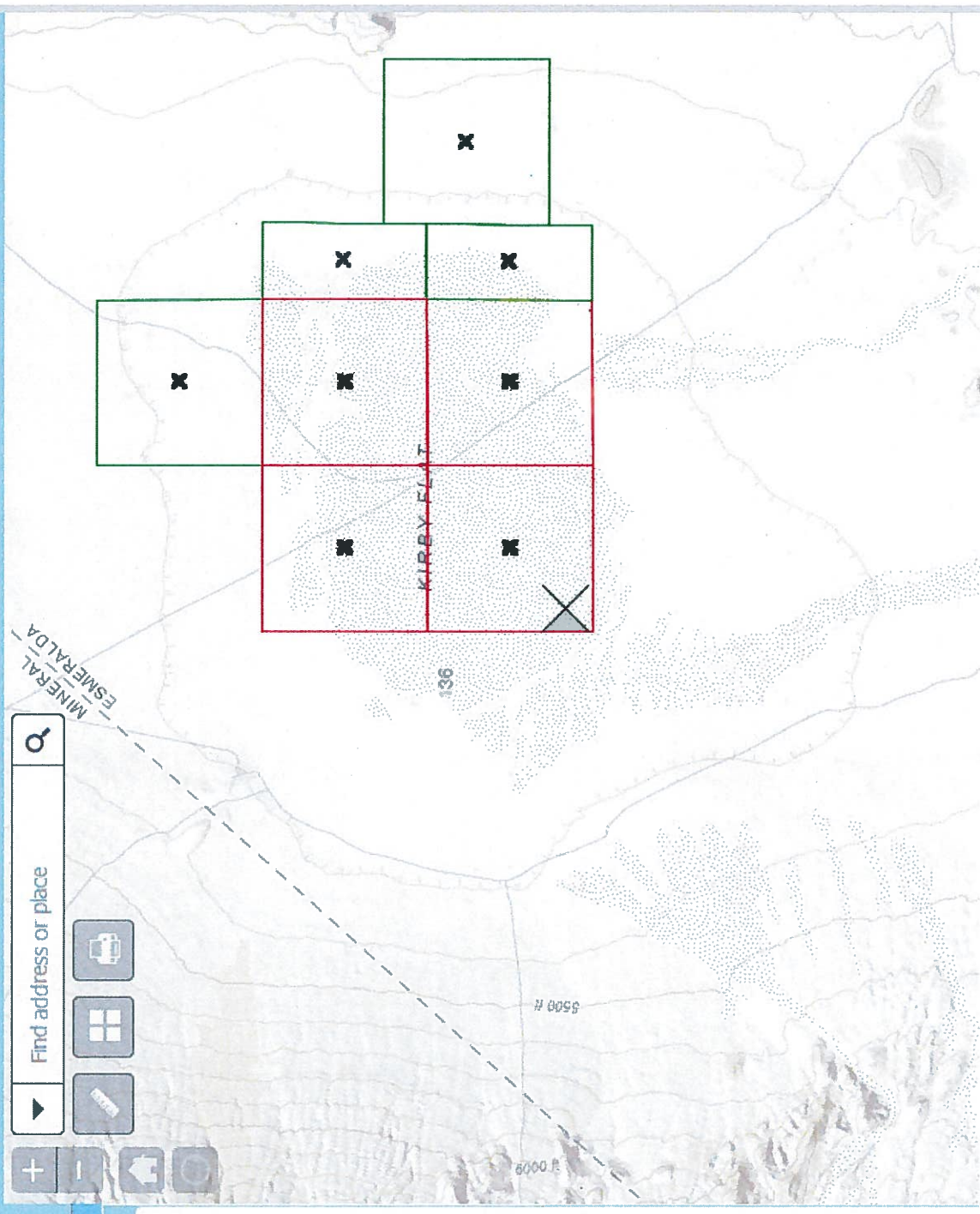
