Planned Use of Geothermal Resource:				
Size of BOP n/a. This is a research project funded by DOE to learn improved methods for finding geothermal resources hidden below the surface in the Great Basin. Wells will not (are not intended to) flow. Install un-cemented blank closed liner to TD to keep hole open for obtaining downhole temperature equilibrium measurements, filling the hole with freshwater upon completion. Drilling would stop and hole completed safely from the depth where boiling temperature is seen at surface. Hole is cooled by drilling operations enough to proceed safely until this point. See attached program for details.				
Planned Disposal of Spent Geothermal Fluid:				
Fluids are not expected from a TG well in this area at the proposed drilled depths. Any cuttings with water based mud materials will be captured at surface and then spread evenly over the drill site as part of the site abandonment procedure, which is planned/budgeted prior to (as a requirement of) closing of INGENIOUS grant. If freshwater aquifer is encountered, it will be managed and cemented at surface. Freshwater aquifer is deepest max 272' (83 m) in this area.

## **CONDITIONS OF PERMIT**

- All permittees must comply with appropriate sections of the Geothermal Rules and Regulations of the Division of Minerals and with applicable rules and regulations of other local, state, and federal agencies.
- 2. During the drilling of domestic geothermal wells, all water strata above the geothermal horizon being used must be sealed or separated in order to prevent their contents from passing into other strata.
- 3. All fresh water and water of value or possible value for other beneficial uses must be confined to their respective strata and be adequately protected by methods approved by the Division. Precautions must be taken in drilling and abandoning wells to guard against any loss of fresh water from the strata in which it occurs, and the contamination of any fresh water by objectionable water.
- 4. The operator of any well must shut off and exclude all water from any geothermal resource-bearing stratum to the satisfaction of the Division.
