II. WORKSHOP

The Nevada Division of Minerals will be holding two workshops pertaining to the amendment of certain regulations relating to its Abandoned Mine Lands Program in Chapter 513 of Nevada Administrative Code. The proposed changes increase the fee imposed on filings of mining claims by \$1.50 per claim to fund activities in the abandoned mine lands program per NRS 513.094, revise the provisions of rating and ranking dangerous conditions, revise the requirements for posting warning signs and methods of securing dangerous conditions, and repeals obsolete language.
