RE: Workshop on Proposed Temporary Regulation changes pertaining to Oil and Gas (NAC 522)

Pursuant to Governor Sisolak's March 22, 2020, Declaration of Emergency Directive 006, Directive 018 (5/7/2020), Directive 021 (5/28/2020), Directive 026 (6/29/2020), and Directive 029 (7/31/2020) the requirement contained in NRS 241.023(1)(b) that there be a physical location designated for meetings of public bodies where members of the public are permitted to attend and participate is suspended in order to mitigate the possible exposure or transmission of COVID-19 (Corona Virus). Accordingly, the Commission on Mineral Resources meeting will be held electronically. Details on how to participate in the meeting is detailed below.

The Division of Minerals will hold a workshop to receive input on proposed temporary changes to Chapter 522 of the Nevada Administrative Code revising regulations relating to reducing the administrative fee on oil production from \$0.15 to \$0.05 per barrel of oil.
