A. Approval of the meeting minutes from the February 20, 2025, meeting

III. Agency Business

A. Legislative Update

Robert Ghiglieri provided the commission with updates from the current legislative session. Rob covered the governor's priorities, general natural resources bills, and mining related bills. He noted that the Division's GIS Analyst is assisting the governor's office and BLM on a collaborative land disposal data sharing project. He went into detail on certain natural resources and mining related bills and where each is at in the legislative process.

B. Rulemaking Process Review

Greg Ott briefed the commission on the Nevada administrative rulemaking process review. He covered the laws that apply to rulemaking, types of rulemaking, and the regulation promulgation process. **Robert Ghiglieri** stated that the agency hasn't gone through rulemaking since 2019. The agency will continue to review its administrative code in accordance with executive order 2023-003. **Greg Ott** recommended looking at the bottom of the NAC to see when it was created and to look at both older codes and very new ones that haven't been tested.

C. Proposed Agency Rulemaking

Robert Ghiglieri proposed updates to specific NAC's pertaining to Geothermal, Oil & Gas, and Reclamation. Rob first discussed regulations recommended for update that may have processes streamlined to increase efficiency and reduce duplicative efforts. Arthur Henderson mentioned this was the second time it was requested to look at these NAC's and that he tried to follow the Governor's office recommendations and expectations. He said that he went through the regulations several times and thinks this is everything that can be modified. Robert Ghiglieri segued into discussing regulations proposed to be updated due to changes in technology. Most changes related to update code relating to geothermal, including well stimulation and induced seismicity. He then discussed other miscellaneous changes to code including moving the date for Annual Status and Production reporting to February 16th. Josh Nordquist asked if we knew if the data is the same as taxation. Robert Ghiglieri said that this information is already required to be reported to the USGS on a quarterly basis and should be provided to the Division sooner. The regulation was created in 1989 and hasn't been updated since then. Mary Korpi expressed concern that some of the companies don't want their information out before it is reported to their investors. Simon Jowitt suggested that there be some agreement between the Division of Minerals and industry that data would not be published until a specified date. Robert Ghiglieri agreed. He then echoed what Greg Ott stated earlier about turnover with State agencies and how this topic may have come up years ago and not pursued for a good reason. He believes it should be moved up so that the data can be made available to the public sooner. He continued the presentation by discussing long term goals to update certain agency statutes. Arthur Henderson asked Robert Ghiglieri to clarify if he is requesting to start the workshop this July. Robert Ghiglieri requested that the commission authorize the Division to start the rulemaking process initially for NACs 534A, 534B, 513, and 519A. He anticipates having a workshop over the summer. Arthur Henderson asked for clarification that the workshop would begin in July or August. Robert Ghiglieri affirmed, pending availability of commission members and staff. The workshop includes stakeholders, industry, NGOs, other state agencies, and others. He anticipates starting in mid-July would be the earliest. Josh Nordquist asked if the commission had any questions. He then instructed the Division to proceed with preparing for the rulemaking process.

D. Agency Budget Update

Garrett Wake updated the commission with the agency's current budget. Robert Ghigleri noted that there seems to be around a twenty percent decrease in placer claims this year. Garrett Wake continued the presentation, stating that the agency's earlier projections of seeing a decrease in mining claim fees around five percent are still holding. He detailed the agency's current and projected revenue and expenditures through the end of the fiscal year. He also covered the agency's current contracts. Robert Ghiglieri stated that the budget is sitting right where we projected it with some small changes. The legislative budget for FYs 26 and 27 were approved and closed out as submitted. This included an additional full-time employee and funding for Nevada's dues to join IMCC.

E. Fluids and Bond Pool Database Update

Garrett Wake provided an update to the commission on the progress of the fluids and bond pool database. **Robert Ghiglieri** reiterated that we have the benefit of having our databases built after other agencies to capitalize on preexisting knowledge and code by the developer. **Garrett Wake** stated that \$44,600 was obligated to the bond pool database with \$7,220 remaining; \$45,675 was obligated to the fluid minerals database with \$40,845 remaining. **Robert Ghiglieri** reminded the commission that they also approved the fluid minerals file digitization project. He stated that interns spent the past few months and completed about seventy percent of the scanning. The contract was just approved to use machine learning to identify and separate filetypes within the scanned files. **Garrett Wake** said that the database developer will then use a script to read each file and place the file into its proper permit for future reference and archival. This information could then be made available to the public. **Robert Ghigleri** noted that Governor Lombardo recognized the bond pool database project at the most recent Certified Public Manager graduation as a significant cost savings to the state. **Josh Nordquist** asked if the software foundation was built for the state. **Garrett Wake** responded that the software developer has worked with multiple state agencies developing software for databases and is able to copy the foundation of the software to personalize each database to the specific agency.

F. NBMG Contract Update

Simon Jowitt updated the commission with an overview of the Nevada Bureau of Mines and Geology (NBMG), NBMG funding and budget, federal collaboration and current ongoing contracts, current research and projects, updates at the Center for Research in Economic Geology (CREG), recent news publications with quotes from Simon Jowitt, update on critical metals and minerals funding and projects, recent publications in partnership with the Division, federal geophysical data acquisitions within Nevada, CREG challenges and uncertainty, and return on investment for investing in geophysical data. Robert Ghiglieri asked Simon Jowitt for this presentation and discussed the current contracts the Division has in place with NBMG that are already budgeted for over the next biennium. He met with Simon to discuss the annual Mineral Industry report, Exploration Survey, and sample curation, and came to an agreement on timelines and deliverables. Simon Jowitt noted that feedback on what the NBMG is producing helps and improves future reports. Nigel Bain asked Simon Jowitt when he goes to PDAC or other conferences if there are different publications that people are interested in regarding mining. Simon Jowitt stated people are after critical minerals and maps of mineral deposits. Simon believes information like this, as well as production information, is very useful. Right now, they don't have the people needed to undertake some of the projects they would like to. Robert Ghiglieri stated that mining is at the forefront of daily conversation like it has never been before. With companies now recycling some of these minerals, what is our capacity to process the product of the recycling facilities as well as an increase in mined minerals like copper. CREG will be a big part of that conversation. Simon Jowitt said there are opportunities happening right now. The UAE is investing four billion dollars in a smelter in Oklahoma. We need to make sure we're on the radar.

G. Copper Processing Study Update

Robert Ghiglieri provided some background on why we were looking to complete a new copper processing report. The Nevada Mining Association worked with the Division of Minerals and Critical Mineral Forum to produce this report; the Mining Association funded the report. Ralston Pedersen presented to the commission on the ongoing copper processing study looking into the domestic smelting and copper manufacturing potential of Nevada. The goals of the project are to inform federal, state and local government, as well as the general public, on the feasibility and economic benefits of building copper processing facilities in Nevada. Robert Ghigleri stated that one of the goals of the report is that when a company is looking to invest in copper processing facilities they look toward Nevada. This would benefit mines to come online but also downstream manufacturing. This is not a fully comprehensive study, but it puts us on display. Bob Felder asked if the Bureau will be publishing the report. Robert Ghigilieri stated that the Division of Minerals is publishing the report. This is the contribution of the Division using an existing statewide contract. The publisher received the draft yesterday and the final is going through peer review. Robert Ghigilieri doesn't feel that this will be the final

report, and this will open doors and open additional opportunities to look at more specific aspects of the supply chain. Conversations around other metal processing are already happening from initiating this study. **Simon Jowitt** asked if anyone has reached out to any major industry players. **Robert Ghiglieri** talked about the potential of the Yerington district. He said this may lead to opportunities for additional research on specific topics and ideas. It's a starting point and with the critical mineral forum's direct connection to the White House they want it as soon as possible.

H. Administrator's Report

Robert Ghiglieri provided his Administrator's report. The State Museum is still working on their mining exhibit with help from Lucia; funding will likely follow next fiscal year. Lucia Patterson received an award from Governor Lombardo, and she was also recognized by the Nevada Women's Fund. There are three projects on the FAST-41 list here in Nevada, companies are using the expedited NEPA process for permitting. Agency had presentations at MALRI, with a Swedish delegation with GOED, U.S. Consulate General in Toronto, and the U.S. Commercial Services of Canada. EPA is advancing the Good Samaritan program and Robert Ghiglieri did a press release with NV Rep. Susie Lee on the act's passage. Carol Shelton received praise from the Clark County School District on the All About Mining virtual course. Agency has a new NEPA viewer on the Division's Open Data website. Geothermal and fluid minerals had the most permits last year since 2011; enhanced geothermal's fruition may mean the agency needs additional staff. NBMG applied for the third round of the USGS Mine Waste study, which helps fund NDEP's AML program. The Division has received unofficial notification of receipt of the first AML program hard rock grant from the Department of Interior at \$200,000 to the Division for closure work and \$500,00 to NDEP for inventory work. AML interns started; the Division has eight interns for the first time in years. The Division assisted the National Association of Abandoned Mine Lands Programs and Interstate Mining Compact Commission to produce a comprehensive nationwide AML hard rock report which should be published in August.

IV. Commission Business

A. Correspondence to the Commission

Robert Ghiglieri recognized Mary Korpi for her longstanding work and dedication as a commissioner as she is not renewing her status as a commissioner next term. **Mari Korpi** said she was honored to serve as a commissioner and how important the Division is. **Josh Nordquist** thanked Mary and recognized her contributions. **Bob Felder** asked about succession planning for the position. **Robert Ghiglieri** stated that there are applications but no confirmation. He said that all commissioners have reapplied for their terms except for Mary. He stated that the Division mails out monthly reports to the commission and other stakeholders and asked if they wanted the Division to send the reports out to anyone else.










Eureka County Population State Demographer Certified

Overview

- NDOM accepted the Western Mine Development (WMD)
 Kingston Mill Plan-level bond into the pool in May of
 2000
- The BLM issued a Decision terminating the Kingston Well Plan of Operation on June 27, 2006. NDOM terminated the WMD bond due to non-payment the same year.
- Earthwork was completed on site by WMD but an abandoned water well and septic tank remained
- NDOM staff, along with members of NDEP and BLM, visited the Kingston Mill site in November 2024 to determine whether NDOM could complete reclamation
- NDOM proposed to complete reclamation work using the existing AML statewide contract
- Approval to perform reclamation work was provided by the BLM-Mount Lewis Field Office on May 22nd



Bidding Process

- The contracted work included plugging and abandoning one water well in accordance with NAC 534.427 and pumping and filling one septic tank in accordance with NDEP's Facility Abandonment Closure Plans, Form WTS-20
- NDOM prepared and released a mini-bid including a scope of work on March 31, 2025, to vendors on the AML statewide contract (99SWC-2513 Scope 13)
- NDOM received two bids and awarded the contract to Broadbent & Associates LLC on May 13, 2025

PROJECT OVERVIEW

To fulfill its mission of identifying and reclaiming public hazards associated with abandoned mining activity, the Nevada Division of Minerals (the Division) is working to reclaim an underground septic tank and water well at the historic Kingston Mill site near the town of Kingston in Lander County, Nevada. The work must adhere to all applicable federal, state, and local laws, regulations, and requirements.

The septic tank must be emptied, filled, and covered to match topography using the Nevada Division of Environmental Protection (NDEP) guidelines (Facility Abandonment Closure Plans, Form WTS-20). The dimensions of the septic tank are unknown.

The water well has a 12" well head and must be plugged and abandoned per NAC 534.427. The cellar is approximately 48" wide by 86" deep and must be backfilled to match topography. Required reporting forms and documentation for plugging and abandoning the water well must be filed and approved by the Nevada Division of Water Resources (NDWR) in accordance with NAC 534.420 and the work shall be performed in accordance with all applicable Nevada Regulatory Statutes and Administrative Codes.

VENDOR SELECTION

Vendors will submit a project plan, including:

- Description of how the vendor proposes to complete the required work, including: equipment required, materials required, personnel required, estimated duration of project, septic tank volume estimation process, and other details pertinent to the completion of the project.
- Cost estimate
- Project timeline
- · Any other details the vendor deems to be pertinent

The Division will review all project plans received and select a vendor. Once a vendor is selected, the Division will schedule a meeting with the awarded vendor to kick off the project and discuss the project.

- Broadbent's initial estimate was \$49,173.71, which included P&A the abandoned water well and filling the septic tank to NDEP standards.
- Broadbent's drilling subcontractor submitted an NOI to NDWR to P&A the well on June 9, 2025. NOI was approved on June 16, 2025.
- Broadbent began reclamation work on June 16, 2025, and finished the work on June 19, 2025, on time.
- During the project, Broadbent discovered a pump still attached to the water well which resulted in filing a Change Order in the amount of \$7,388.08 bringing the total project cost to \$56,561.79





Before and After—Water Well






Before and After—Septic Tank





Funding

- NDOM held \$100,450 in bonding for the Kingston Mill
- This was one of only a few times NDOM has used bond pool funds to reclaim a site
- BLM and NDOM have an MOU for the bond pool which allows either to reclaim, NDOM was able to move quickly, after receiving approval from the BLM, to reclaim the site



Project Closeout

- NDOM has been invoiced for closure work but is awaiting the final report from Broadbent
- Awaiting a Decision letter from the BLM formally acknowledging reclamation work and releasing NDOM from its bond obligation




Final Thoughts

- NDOM's reclamation efforts at the Kingston Mill date back to 2006, but personnel changes delayed the approval process.
- When NDOM contacted BLM again in 2024 to perform reclaim the Kingston Mill, the process moved quickly this time
- NDOM's ability to use an existing statewide contract and still obtain competitive bids allowed us to perform reclamation quickly and efficiently
- From first (restarted) conversations with the BLM, through final reclamation, the process took about seven months
- Once approval was granted, the process took less than 30 days





EXECUTIVE SUMMARY REPORTS

May 2025

Legislation, Industry, and Public Relations: SB464 making Nevada a full member of the Interstate Mining Compact Commission (IMCC) was introduced in early May and was heard in both Senate and Assembly Natural Resource Committees being passed out of each committee unanimously. The Bill was also passed out of each respective house unanimously and sent to the Governor for Signature in early June. The Commission held a quarterly meeting and introduced the concepts for Geothermal and Dissolved Mineral Resource rulemaking. The Administrator participated in roundtable with GOED, UNR, EDAWN, and other regional development authorities, and delegations and business from Sweden on their opportunities for business development in Nevada. Participated in other various meetings and committees not mentioned above to include NBMG, IMCC, SEC, EPA, geothermal industry members, Clean Air Task Force, MMSA, The Nature Conservancy, NvMA, NDEP, BLM, AEMA and various members of the public and minerals industry.

Abandoned Mine Lands (AML): AML staff conducted two weeks of program, safety, and field training with summer interns and inventoried and secured hazards in Lyon County. AML contractor EPS completed safeguarding project work in Mineral, Storey, and Lyon counties including 43 securings. 





EXECUTIVE SUMMARY REPORTS

June 2025

<u>Legislation, Industry, and Public Relations:</u> SB464 and AB 277 were both signed into law by Governor Lombardo. SB464 established Nevada as a full member of the Interstate Mining Compact Commission and will become effective July 1, 2025. AB277 exempted the annual Net Proceeds of Minerals Tax Bulletin publication from confidentiality at the Department of Taxation. The Administrator attended a Mineral County Commission meeting with Congressman Amodei to discuss exploration and mining activities in the County. The Administrator and Agency Analyst both attended the Interstate Mining Compact Commission in Gillette Wyoming.

<u>Abandoned Mine Lands (AML):</u> AML staff conducted 4 weeks of field work with summer interns and inventoried 219 hazards in Esmeralda, Nye, Mineral, Lander, and Elko Counties. AML staff held meetings with four stake holders and others for site selections and project proposals in consideration of the Union mine Good Sam project proposal. 


