NOW THEREFORE, If said Principal, in its operations after the execution of permit by the Division, shall fully comply with said NRS Chapter and the rules and regulations of the Division of Minerals of the State of Nevada prescribed to govern the activities of geothermal within the State of Nevada, then, and in that event, the above obligation shall be void, otherwise to remain in full force and effect.
