




Nevada Production Data 1987 - 2022








2022 AU % BY LAND OWNERSHIP



% AU BY PROCESS (2021 VS. 2022)

















Mining Claims Distribution



Conservation rule

- Record number of comments received (216,000 in total -22,000 being substantive)
- It has been stated that the rule has a long time to go, it has caught <u>a lot</u> of attention
- Estimated that it would probably 18-24 months (that figure was as of mid august) to even have an answer which doesn't include a final draft.

Security Exchange Commission - Natural Asset Company Rule



The NAC Rule defines a NAC as:

"Corporations that hold the rights to the ecological performance of a defined area and have the authority to manage the areas for conservation, restoration, or sustainable management."

The exchange states that these rights could be licensed like other rights including "run with the land" rights such as mineral rights, water rights, or air rights[.]"

NAC Rule clearly conveys that ecological performance rights would be inclusive of public lands stating:

"If the NAC has entered into a license agreement with respect to public lands, shares representing at least 50% of the shares of the NAC's outstanding shares as of the closing of the IPO must be distributed to local communities." (FR at 68815)

Truckee Meadows Public Lands Management Act: Proposed **Development and Conservation**

TRUCKEE MEADOWS PUBLIC LANDS MANAGEMENT ACT

- 1,053,895 acres proposed for withdrawal within the act including wilderness and NCA designations
- NCA's and wilderness overlap existing WSA designations but not entirely
- It is not clear if WSAs become NCA/WSA and if the "leftover" WSA designations stay "as is". There is no specification of any WSA release (but read this again)

CEQ Proposed NEPA Rule




- Letter submitted Governor's office
- Waiting on Final draft
- Proposal to increase permitting time
- Lack of regulatory stability disastrous for economic
 Development (need confidence and certainty in NEPA)
- Increases opportunities for litigation
 Will result in Economic impacts to local economies
- Allows for projections and assumptions to be acceptable forms of environmental analysis
- Requires more information with a smaller overall document size






