City of Sparks

- 865 acres of Federal land subject to valid and existing rights.
- Use-public purposes (parks, open space, and cemeteries)
- If not used consistent with the Act of June 14, 1926 (Recreation and Public Purposes Act) the land will revert back to United States

City of Reno

- 266 acres of Federal land subject to valid and existing rights.
- Use-public purposes (parks, effluent storage, roadway expansion)
- If not used consistent with the Act of June 14, 1926 (Recreation and Public Purposes Act) the land will revert back to United States

Washoe County

- 1,844 acres of Federal land subject to valid and existing rights.
- Use public purposes (open space, trails, public shooting facilities)
- If not used consistent with the Act of June 14, 1926 (Recreation and Public Purposes Act) the land will revert back to United States

School District

- 105 acres of Federal land subject to valid and existing rights.
- Use public purposes (elementary and middle school sites)
- If not used consistent with the Act of June 14, 1926 (Recreation and Public Purposes Act) the land will revert back to United States

Incline Village

- 14 acres of Federal land subject to valid and existing rights.
- Use incline village general improvement district and public purposes (fire reduction activities and open space)
- If not used consistent with the Act of June 14, 1926 (Recreation and Public Purposes Act) the land will revert back to United States

Nevada Department of Wildlife

- 1,311 acres of Federal land subject to valid and existing rights.
- Use expansion of wildlife management areas.

• If not used consistent with the Act of June 14, 1926 (Recreation and Public Purposes Act) the land will revert back to United States

State Lands

- 215 acres of Federal land subject to valid and existing rights.
- Use public purposes (state park)
- If not used consistent with the Act of June 14, 1926 (Recreation and Public Purposes Act) the land will revert back to United States

Truckee River Flood Management Authority

- 240 acres of Federal land subject to valid and existing rights.
- Use public purposes (flood mitigation and scour protection)
- If not used consistent with the Act of June 14, 1926 (Recreation and Public Purposes Act) the land will revert back to United States

University of Nevada, Reno

- 1 acre of Federal land subject to valid and existing rights.
- Use public purposes (campus expansion)
- If not used consistent with the Act of June 14, 1926 (Recreation and Public Purposes Act) the land will revert back to United States

Sale of Certain Federal Land

- Disposal of 14,606 acres selected by the secretary and the county.
- Proceeds
 - 5% to state education programs
 - 10% to county for conservation projects along the Truckee River
 - 85% in United States treasury into "Truckee Meadows Special Account" for acquisition of environmental Sensitive lands, NCA designations under this act, park development, fuel reduction, environmental restoration

Tribal Trust Land

- Pyramid Lake Paiute Tribe 11,473 acres to Tribe
- Reno-Sparks Indian Colony 8,787 acres
- Washoe Tribe of Nevada and California 2,177 acres
